ORDER

In the Budget proposal for the year 2010-11, an amount of ₹ 400 lakhs was provided under Plan Grant -in-aid for Malabar Cancer Centre for procurement of MRI Scan, Kerala Water Supply scheme and Establishment of Nuclear Medicine Lab. The fund earmarked is inadequate for the above purpose.

In the circumstances the Director, Malabar Cancer Centre submitted a revised proposal of ₹ 274 lakhs before the working group held on 19/07/10. As advised by the working group the proposal forwarded to Planning and Economic Affairs Department and Finance Department.

The Planning Department had approved the deviation under the Plan as proposed by the Director, Malabar Cancer Centre. As per the GO(Rt) No. 4516/2010/H&FWD dated 18/11/2010 Administrative Sanction has been given for an amount of ₹ 274 lakhs.

The proposal submitted by the Director, Malabar Cancer Centre to accord Administrative Sanction for an amount of ₹ 76 lakhs for the year 2010-11 and the working Group approved the proposal by the Director, Malabar Cancer Centre as detailed below was also considered by the working Group in the meeting held on 08/10/10 and approved as such:-
