ORDER

As per the Government Order read as 1st paper above Government have established a Medical University in Kerala under the name of “Kerala University of Health and Allied Sciences” with headquarters at Thrissur, for all the systems of Medicine viz, Modern Medicine, Ayurveda, Homeopathy, Unani, Sidha and allied subjects. As per the Notification read as 5th paper above Government have promulgated an Ordinance 2010 for the purpose. The University is temporarily functioning in the campus of Medical College, Thrissur. The issue of making available land to the University including sparing of land to the Avanoor Grama Panchayat on public interest was discussed in the high level meeting convened on 11.3.2010 with all concerned and it was decided to hand over 75 acres of land out of the 237 acres available with Medical College, Thrissur to the University and land for constructing a ring road of 8 metres width including the existing Panchayat road, and to acquire 15 acres of land additionally. Accordingly the District Collector, Thrissur and Registrar, Kerala University of Health And Allied Sciences (KUHAS) have submitted proposals to Government, for sparing of land. The Registrar, Kerala University of Health And Allied Sciences (KUHAS) has reported that on further survey, only 63.60 acres of land is available for transfer to the University.

2) Government have examined the proposal in detail and are pleased to issue the following orders:

- i) Permissive sanction is accorded for handing over 63.60 acres of land (25.7399 Hectares) from the campus of Medical College, Thrissur to the Registrar, Kerala University of Health and Allied Sciences, Thrissur, subject to the condition that the ownership of the land will be retained with the Health and Family Welfare Department i.e., Principal, Medical College, Thrissur.

ii) Permissive sanction is also accorded for handing over the land from Medical College, Thrissur at the outer periphery to Avanoor Grama Panchayat to construct a public road encompassing a total width of 8 metres including the existing Panchayat road out of the 63.60 acres of land now sanctioned to Kerala University of Health And Allied Sciences (KUHAS). The ownership of the land assigned for ring road by the Medical College also will remain with the Principal, Medical College, Thrissur. The said public road will be maintained by the Avanoor Grama Panchayat


3) The District Collector, Thrissur will take further necessary action in the matter.
