ORDER

In partial modification to the Government order read as 6th paper above, the 3rd para of the Government order is modified and will be read as follows:-

3. Government have examined the matter and order that the employees working in Health Service Department in the categories of Head Nurse, Staff Nurse Grade-I & Staff Nurse Grade-II, who have not filed option within the stipulated time as per Government order read 2nd above and those who had filed options but were not accepted due to various reasons, will also be permitted to submit fresh option. The employees in the categories of Head Nurse, Staff Nurse Grade-I & II shall file their option in the prescribed form appended to this order, to the Head of the respective Institution before **5 pm on 05.07.2010**. The District Medical Officers will forward the duly filled up option forms countersigned by the District Medical Officer/respective Head of Office, to the Administrative Officer (Dual Control Option Cell), Office of the Director of Health Services, Thiruvananthapuram so as to reach the office on or before **09.07.2010 at 5pm**. Extension of time or cancellation of option exercised earlier will not be allowed.

2. The Government order read as 6th above is modified to the above extent.


