Clause VII (a) 2 is modified as follows -

"Provided however that period of deputation of Health Service Department candidates to autonomous institutions/projects/societies other agencies under the administrative control of health department will be counted as eligible service for service quota under SSQ".

The 2nd paragraph of clause IX (a) (ii) is modified as follows -

"The list of remote/difficult areas shall be as per GO(MS)No. 13/2010/H&FWD dated 14.01.2010. The weightage for service in remote/difficult areas shall be given to those doctors who are working in the

stations annexured to the above order only. GO(P)No.70/03/H&FWD dated 09.04.2003 will not be applicable to the above purpose.

The weightage for service in remote/difficult areas shall be given to all candidates appeared for the Entrance examination for the purpose of ranking, if they have remote/difficult area service, irrespective of the fact that, they have not obtained the mandatory minimum of marks in the entrance examination.


The prospectus for admission to Postgraduate Medical Courses 2010 is modified to the above extent.
