ORDER

As per Government order read above, Revised Administrative Sanction was accorded for the purchase and installation of a 2/4 slice or 4/6 CT Scanner for the Department of Radiodiagnosis, Medical College, Alappuzha limiting to the funds available with the Cancer Care Society, Alappuzha. Accordingly Director of Medical Education has forwarded a proposal for the purchase of same and requested to accord sanction by entrusting Kerala Health Research & Welfare Society to purchase the same as done for Government Hospital, Manjeri at a total cost of Rs.1.386 Crores.

2. Government have examined the matter in detail and are pleased to order that the KHRWS, will purchase and install a 2/4 slice CT Scanner for the Department of Radiodiagnosis, Medical College, Alappuzha at a total cost of Rs.1.386 Crores including 5% service charge from M/s.Siemens Limited, Chennai. No fresh tender will be invited and purchase the machine as per the same rate for which it was procured on the strength of tender submitted by the firm for Panakkad Shihab Thangal Smaraka Government General Hospital, Manjeri.

3. Of the total expenditure Rs.One Crore will be met from District Cancer Care Society and the balance will be met from Hospital Development Society fund, Medical College, Alappuzha. The purchase shall be made strictly by observance of Store Purchase Rules.
